Introduction

The Bar Council is the voice of the barrister profession in England and Wales. We lead, represent and support the Bar in the public interest, championing the rule of law and access to justice. Our nearly 18,000 members – self-employed and employed barristers – make up a united Bar that aims to be strong, inclusive, independent and influential.

As the General Council of the Bar, we're the approved regulator for all practising barristers in England and Wales. We delegate our statutory regulatory functions to the operationally independent Bar Standards Board (BSB) as required by the Legal Services Act 2007.

Pupillage is the work-based component of training to become a barrister. It's the final stage of training, after both the academic stage in the form of a law degree or conversion, and the vocational component of training - the Bar course.¹ Securing pupillage is highly competitive. Between 500 and 600 pupils start pupillage each year.

The Pupillage Gateway is our advertising and recruitment portal. It's used by Authorised Education and Training Organisations (AETOs) to advertise vacancies and recruit aspiring barristers for pupillage at the Bar. All pupillages are advertised via the Gateway (advertising on the Gateway is required by the BSB, but recruitment is not).² At present, 60% of AETOs also use the Gateway for recruitment. Those AETOs who do not use the Pupillage Gateway for recruitment manage their own recruitment process directly.

Every year, pupillage vacancies are advertised on the Gateway towards the end of November. AETOs begin accepting applications from candidates in January of the following year. Candidates have around one month to submit their pupillage applications to the AETOs, either via the Gateway or directly. From February to April, this is when the selection process takes place. Successful candidates will receive their offers in May.

Aspiring barristers use the Pupillage Gateway to apply for pupillage vacancies. To apply for pupillage, candidates must be confident that they will have completed the vocational component before the date the pupillage is advertised to start. Alternatively, they must have secured a waiver from the BSB.³ To start pupillage, applicants must have completed the vocational component within the last 5 years (unless they have a waiver from the BSB). In a typical year, over half of applicants apply for pupillage having not yet completed the vocational component.

The Pupillage Gateway is a valuable source of data on: (i) pupillage vacancies; (ii) the profile of candidates applying for pupillage; and (iii) the progression of candidates of different backgrounds through each stage of the recruitment process (with chambers and employers recruiting via the Gateway).

The data shown in this report is for the 2024/25 recruitment round (between 25 November 2024, when vacancies were advertised, and 9 May 2025, when initial offers were made). It combines data from AETOs that were recruiting pupils to start pupillages primarily in either autumn 2025 or autumn 2026.

This report supports our mission to lead, represent and support the Bar in the public interest, and to champion the rule of law and access to justice for all. Our report offers valuable insights into the experiences and progression of aspiring barristers from diverse backgrounds. The findings help chambers, AETOs, and policymakers make informed, evidence-based decisions, and contribute to our aim of building a strong, inclusive and resilient profession. Through identifying trends, the report reflects our core values of diversity, inclusion, and excellence, helping shape a Bar that is representative of the society it serves.

Key findings

- The number of pupillages advertised during the 2024/25 recruitment round was 683 (compared with 671 in 2023/24), a 1.8% increase
- The total number of pupillages registered in 2024 has increased by 6.8%. Whilst the number of pupillages registered in chambers has decreased, the number of pupillages registered at the employed Bar have increased and now make up 20.5% of all registered pupillages
- Nearly a quarter of applicants (24.2%) said that they expect to have no debt (including student debt) on completion of pupillage, whilst over half of respondents (53.9%) indicated that they are anticipating some level of debt
- Women represented 57.6% of all applicants and secured 51.2% of offers recorded on the Pupillage Gateway in 2024/25, a decrease compared with the previous year. Men represented 38.7% of applicants and secured 46% of offers recorded on the Gateway, an increase compared with the previous year
- Between 2023/24 and 2024/25, the overall proportion of pupillages offered to Asian/Asian British candidates rose from 7.3% to 10.5%, whilst offers to Black candidates increased slightly from 2.7% to 3.1%. The number of offers that went to candidates of mixed ethnicity remained stable at around 9%. White candidates experienced a small decline in offers from 75.5% to 74.2%
- 11.8% of the offers recorded on the Pupillage Gateway were made to applicants with a disability, a decrease from 14.6% in 2023/24, but still an increase compared with 2022/23 (10.4%)
- Nearly half (49.5%) of all applicants went to state schools (non-selective and selective), around 16% went to independent or fee-paying schools (with or without scholarship), and about a quarter (26.5%) attended school outside the UK
- Candidates with scholarships from one of the Inns of Court have remained over 4 times more likely to receive offers than those without since 2022/23
- 54% of those who received an offer had a first-class honours degree, compared with 38% who had an upper second-class (2:1) degree. For the first time in our recorded

data, 1% of candidates with a lower second-class honours degree received offers in the 2024/25 recruitment round

- Applicants who had undertaken work experience or a mini-pupillage were 4 times more likely to receive a pupillage offer than those who had not
- Candidates with lower grades in the Bar course have notably lower success rates in securing pupillage offers

Data notes

Section A: vacancies

Besides a small number of waivers, all AETOs must comply with the same pupillage offer timetable, and all AETOs must advertise their pupillage vacancies on the Pupillage Gateway.⁴ However, AETOs can conduct their own selection process outside of the Gateway and we therefore don't hold any data on their recruitment processes, apart from the information within their adverts. Whilst AETOs are not required to record recruitment on the Gateway, when they do so, we are able to provide more accurate data on success rates, helping us build a clearer picture of access and progression across the profession.

Chambers and organisations must advertise on the Pupillage Gateway, so we hold information on the number of posts advertised, specialism, location, and the pupillage award amount. The vacancies in the 2024/25 pupillage round include vacancies for pupillage starting in autumn 2025, and in autumn 2026. However, a small number start at other times.

In 2024/25, 133 chambers/organisations used the Gateway for pupillage recruitment against 90 who advertised only. We do not hold data relating to AETOs that have secured an advertising waiver for either a full or partial pupillage. This explains the disparity between the total number of pupillages offered through the Pupillage Gateway and the higher number of registered pupillages published by the BSB (by comparing Figure A.1 of this report to Figure B.2).

AETOs may change their main practice area from time to time, so we can only establish limited comparisons about change over time in relation to practice area.

Section B: applicants and pupillages

This section includes information on candidates who applied to AETOs on the Pupillage Gateway during the 2024/25 recruitment round (between November 2024 and February 2025). Almost all applications were for pupillages starting between October 2025 and October 2026.

This data accurately represents almost all pupillage applicants in any given recruitment round because most candidates – even those who do not ultimately secure a pupillage via the Gateway – will make at least one application through the Pupillage Gateway.

As we only hold data on those AETOs who use the Pupillage Gateway to recruit, we do not have data on AETOs who only advertise. We have included data on registered pupillages and AETOs held by the BSB (Figures B.2 and B.3).

Section C: outcomes

As we do not have data on AETOs who recruit outside the Gateway and only data on AETOs that use the Gateway to support their recruitment process, the data in this section is not comprehensive and comes with limitations. We only have data on candidates who were offered pupillage via the Gateway; we do not have data on those who received pupillage offers outside of the Gateway process. Consequently, we have drawn tentative conclusions based on the data available.

The practice areas have been established based on the specialisms that each AETO falls under in our database, based on information collected from practitioners' responses during the annual Authorisation to Practise process.

We have chosen to include data here for protected characteristics, indicators of socio-economic background, and education background in this section. For protected characteristics, we have included data on sex, race, and disability. For socio-economic background indicators, we have included data on parental background based on occupation of highest earning parent and type of school attended by the candidate. For educational background, we included data on the type of undergraduate degree, degree classification attained by candidates, whether they had work experience or done a mini-pupillage, their scholarship status, and the grade they achieved during the vocational training stage (Bar course).

We have not included data sets here for protected characteristics or indicators of socio-economic background where 50% or more have answered 'prefer not to say'. This is because the resulting numbers have the potential to be misleading as the lack of data means it's not

representative. Percentages given will not all amount to 100% because we do not account for those who 'preferred not to say'.

For a more detailed overview of progression of candidates, please refer to Section E.

Section D: tables and figures

This section supplements the charts referred to in sections A to C and provides the data in table format for accessibility. It also provides additional charts for different practice areas. For example, the data illustrated in Figure A.1 can be found in Table A.1 in this section, Figure A.2 in Table A.2, etc. Some of the percentages given will not amount to 100% as we have excluded no responses or those who indicated 'prefer not to say'.

Section E: datasets for protected characteristics and social mobility (including by practice area)

This section includes the underlying datasets for protected characteristics and social mobility. The datasets are also divided into practice areas.

Some of the 'first round', 'second round' and 'offer made' data is compromised. This is in part because some AETOs do not update the status of their candidates at the end of the process. Additionally, some AETOs only run 'first round' interviews so there may be oddities in the data between 'second round' and 'offer made' as some successful candidates do not appear in the 'second round' column and instead jump to 'offer made'.

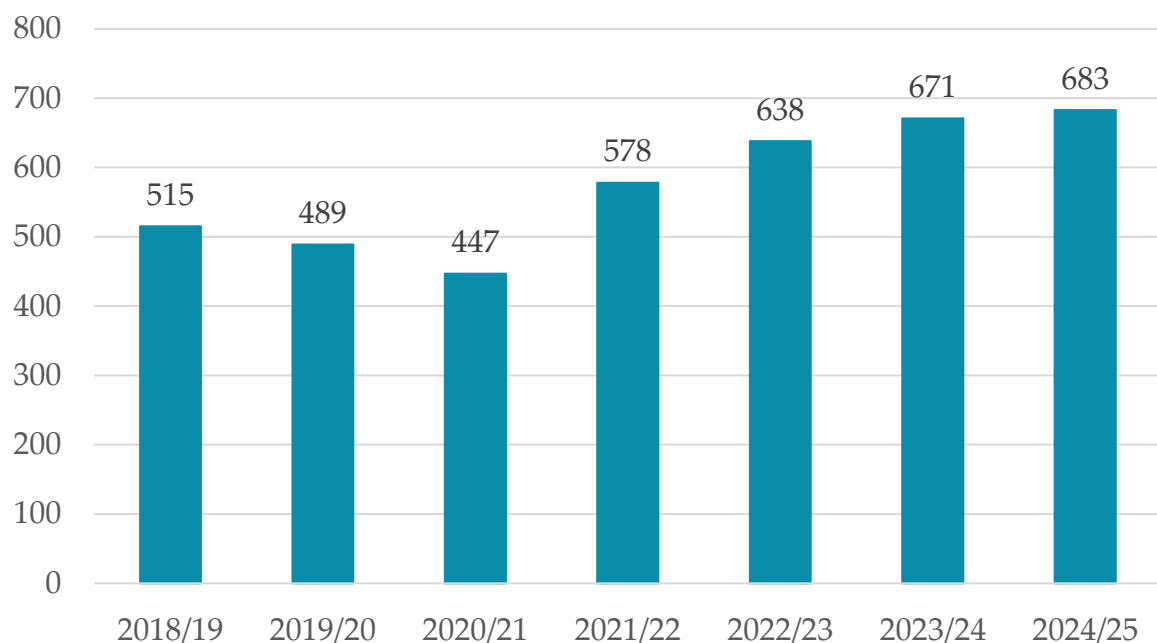
Section A: vacancies

Summary

This section covers the number and type of vacancies advertised on the Pupillage Gateway during the 2024/25 recruitment round. It gives a sense of the recruitment pattern across the Bar year on year as not all AETOs offer pupillages and recruit via the Gateway. It also covers the average (mean) pupillage award made by practice area (see Figure A.4).

Findings

- The number of pupillages advertised during the 2024/25 recruitment round was 683 (compared with 671 in 2023/24), a 1.8% increase compared with the previous recruitment round
- Whilst the number of pupillages advertised has continued to rise since 2020/21 and is now at an all-time high, the rate of increase has slowed

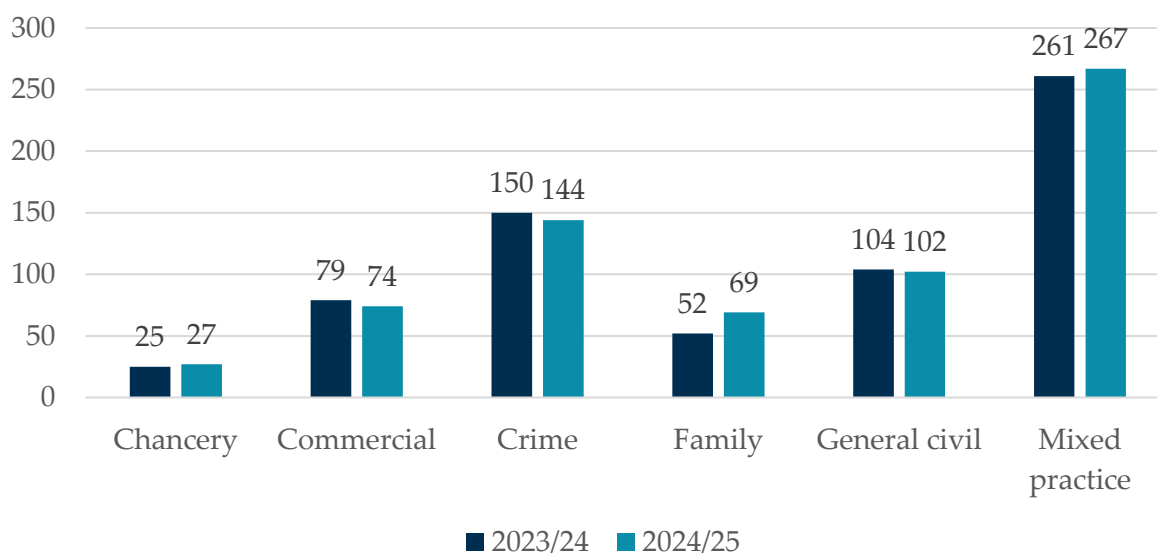

Figure A.3 Positions advertised on the Gateway by practice area, 2023/24 and 2024/25⁷

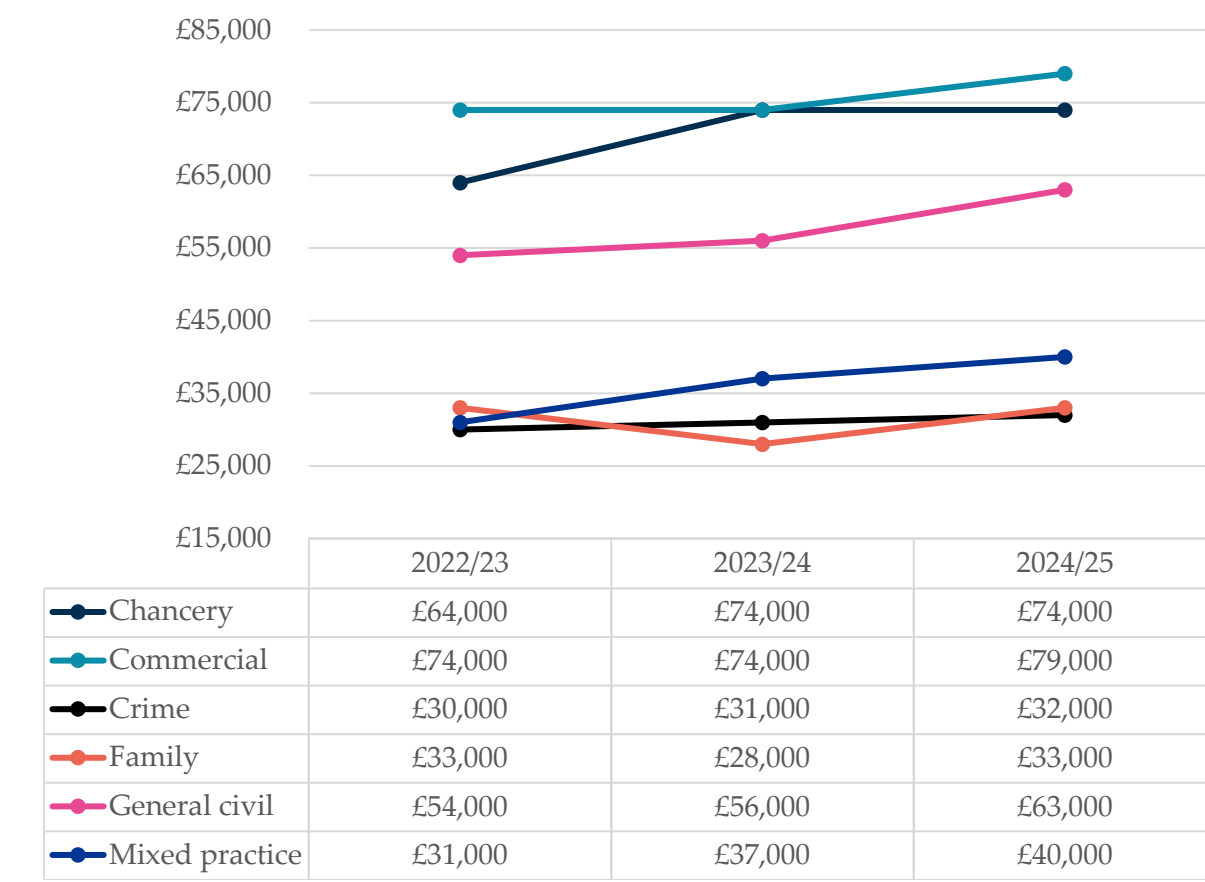


- Whilst the overall number of pupillages advertised increased in 2024/25, numbers fell in some practice areas, such as commercial, crime and general civil, compared with 2023/24

- In 2025, the minimum pupillage award required by the BSB was raised to £24,203 for 12-month pupillages in London and £22,019 outside London, as recommended by the Living Wage Foundation⁹
- Whilst the mean pupillage award across practice areas such as Chancery and crime has remained consistent compared with last year, there were significant increases in commercial (6.8% increase), general civil (12.5% increase), and in mixed practice (8.1% increase)¹⁰

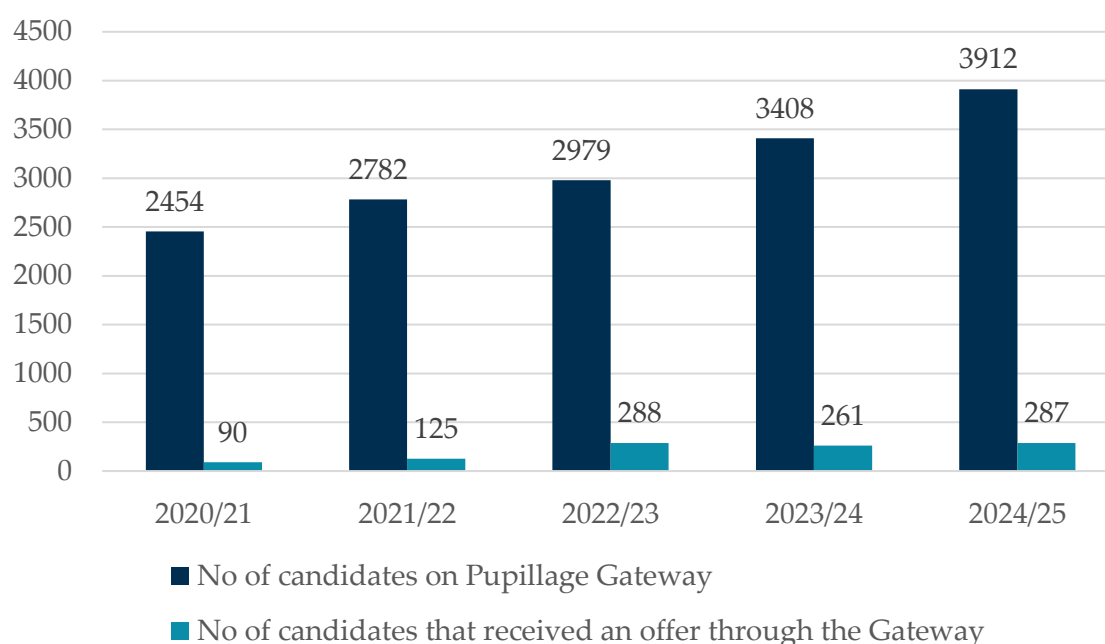

Section B: Applicants and pupillages

This section compares the numbers of applicants with the number of offers made via our Pupillage Gateway, and pupillages started at the Bar. Most aspiring barristers will make at least one application through the Gateway, so the data on applicants covers most of each year's cohort. Around half of all pupillages at the Bar each year are offered via the Gateway.

Findings

- The total number of candidates on the Pupillage Gateway who submitted one or more applications during the 2024/25 recruitment round is 3,912, an increase of 14.8% from the 2023/24 recruitment round
- The number of offers made through the Pupillage Gateway has increased by 10% to 287 in 2024/25 from 261 in 2023/24

Figure B.2 Registered pupillages at the Bar by calendar year and type of employment¹²

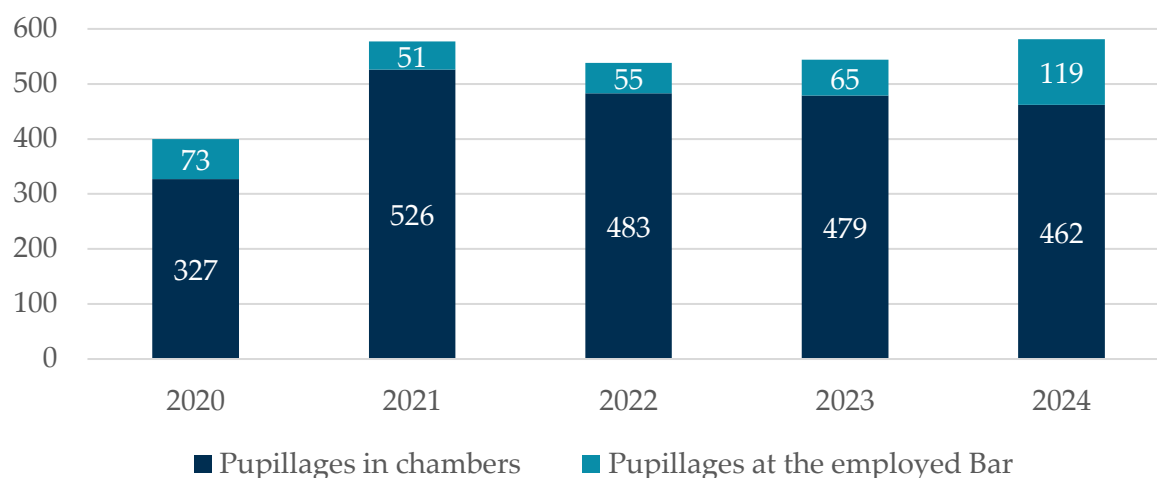
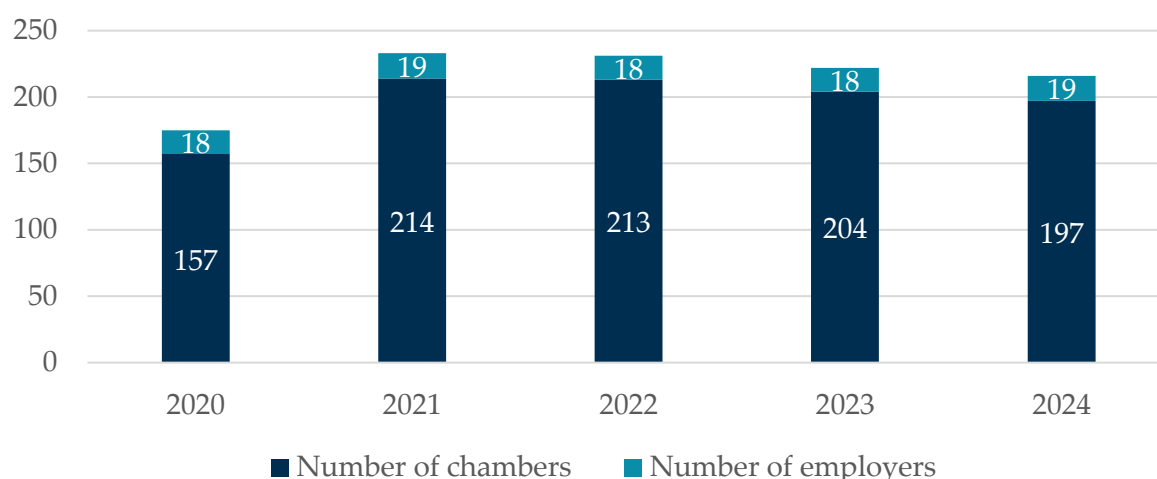


Figure B.3 AETOs (pupillage providers) at the Bar by calendar year and type of AETO¹³



- We have seen a consistent year-on-year increase in the number of pupillages since 2022. Whilst the total number of pupillages in 2024 increased by 6.8% from the previous year, this year there has been a decrease in registered pupillages in chambers of 3.5% (Figure B.2)¹⁴
- In 2024, the number of registered pupillages at the employed Bar increased by 83.1% compared with the previous year
- Pupillages at the employed Bar make up 20.5% of all registered pupillages in 2024
- The total number of pupillage providers (AETOs) in 2024 has decreased by 2.7% compared with 2023, and by 7.3% compared with 2021. This is due to a decrease in

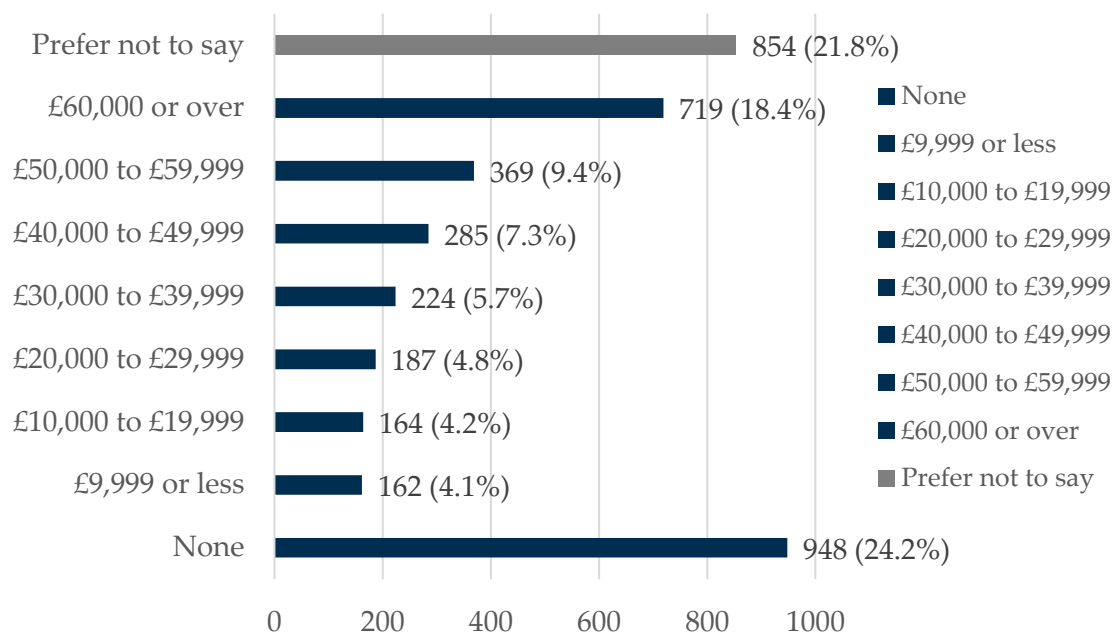

the number of chambers that are AETOs; the number of employers that are AETOs has remained stable

- Nearly a quarter of applicants (24.2%) said that they expect to have no debt (including student debt) on completion of pupillage, whilst over half of respondents (53.9%) indicated that they are anticipating some level of debt
- More than a third of applicants (35.1%) expect to have debt of more than £40,000 on completion pupillage, and nearly a fifth of applicants (18.4%) expect to have debt of £60,000 or more

Section C: Outcomes

These figures collate candidates who applied during the recruitment round that ran between November 2024 and May 2025. In this recruitment round, the pupillages offered through the Gateway make up 55% of pupillages advertised.¹⁶

The outcomes are divided into three sections:

C1) protected characteristics (sex, race and disability)¹⁷

C2) social mobility and finance

C3) education

Where possible, the likelihood of candidate success is given in differential terms. In other places, the data is simply presented. The data in this section (and the accompanying tables in Section D) should be seen as supplementary to the comprehensive data tables in Section E.

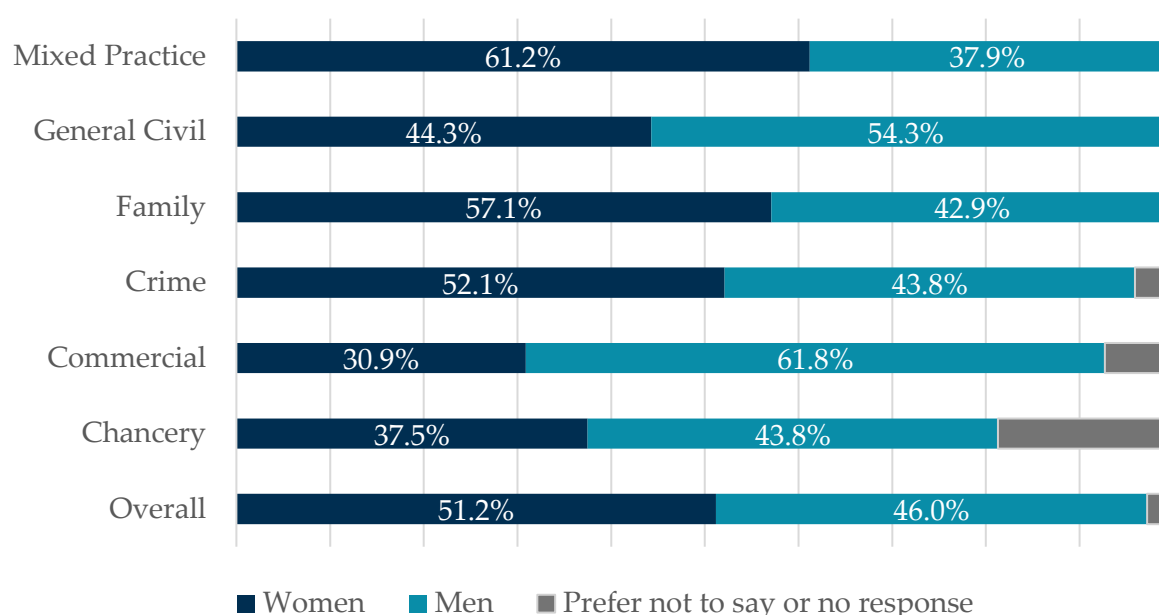

Section C1: outcomes based on protected characteristics

Sex¹⁸

Figure C.1.1 Percentage of pupillages offered via the Gateway by sex and practice area (including overall) in 2024/25



- Women made up 57.6% of all applicants and received 51.2% of recorded offers in 2024/25.¹⁹ Men made up 38.7% of applicants and received 46% of recorded offers
- The proportion of pupillages offered by sex differs between practice area. In mixed practice, more than 60% of pupillages were offered to women in 2024/25. In commercial, 61.8% were offered to men
- In 2024/25, the percentage of pupillages offered to women in crime (52.1%) and family (57.1%) on the Gateway dropped quite significantly from 76.8% in crime in 2023/24 and 76.2% in family in 2023/24. It is worth noting, however, that the number of offers made in these areas is small – 48 and 21 offers in total respectively. In commercial, 17 offers were made to women, and 34 offers were made to men²⁰

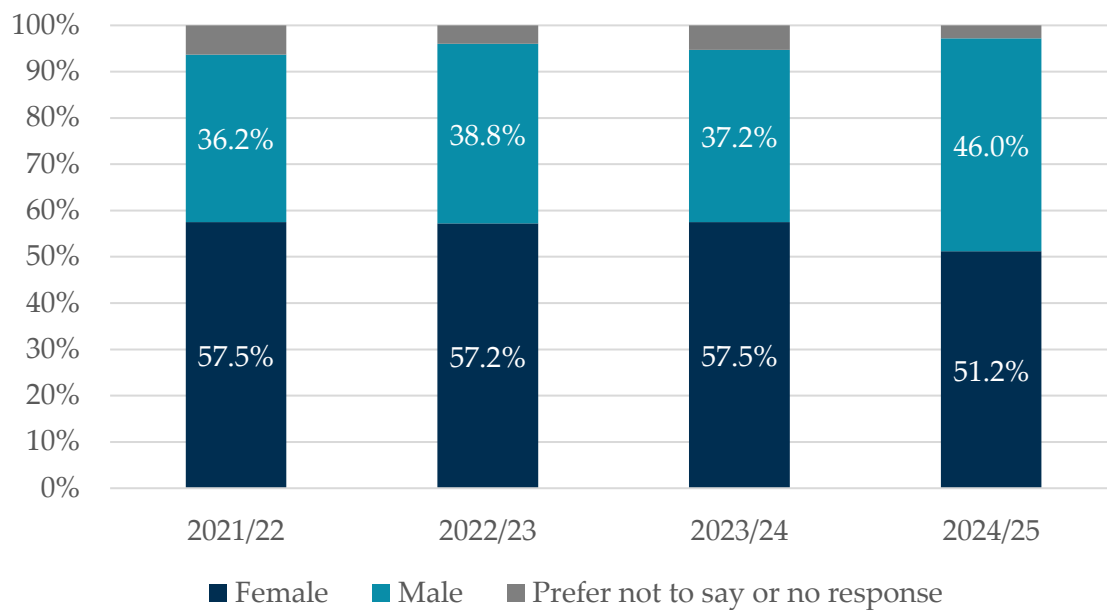

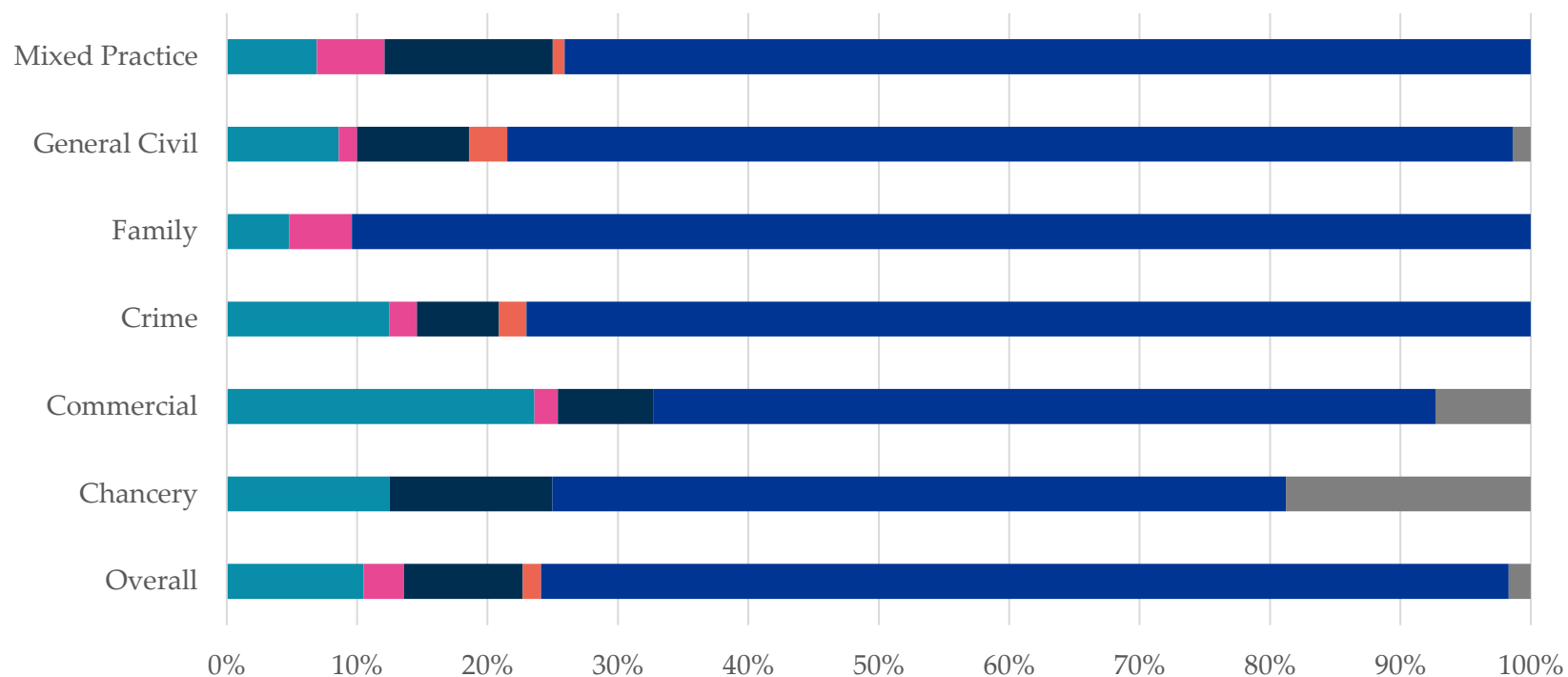
Figure C.1.1.a Percentage of overall pupillages offered via the Gateway by sex from 2021/22 to 2024/25

3,912 applicants applied for pupillage through the Gateway in 2024/25 and 287 candidates were offered a pupillage via the Gateway. The breakdown by ethnicity is as follows:²²

- Asian/Asian British candidates made up 25.2% of applicants, and received 10.5% of recorded offers
- Black/African/Caribbean/Black British candidates made up 10.7% of applicants, and received 3.1% of recorded offers
- Candidates of mixed ethnicities made up 7.5% of applicants, and received 9.1% of recorded offers
- Candidates of 'other' ethnicities made up 3.1% of applicants and received 1.4% of recorded offers
- White candidates made up 48.6% of applicants, and received 74.2% of recorded offers
- 5% of applicants indicated 'Prefer not to say' and received 1.7% of recorded offers

Figure C.1.2.a Percentage of applicants and percentage of candidates who received an offer via the Gateway by ethnicity

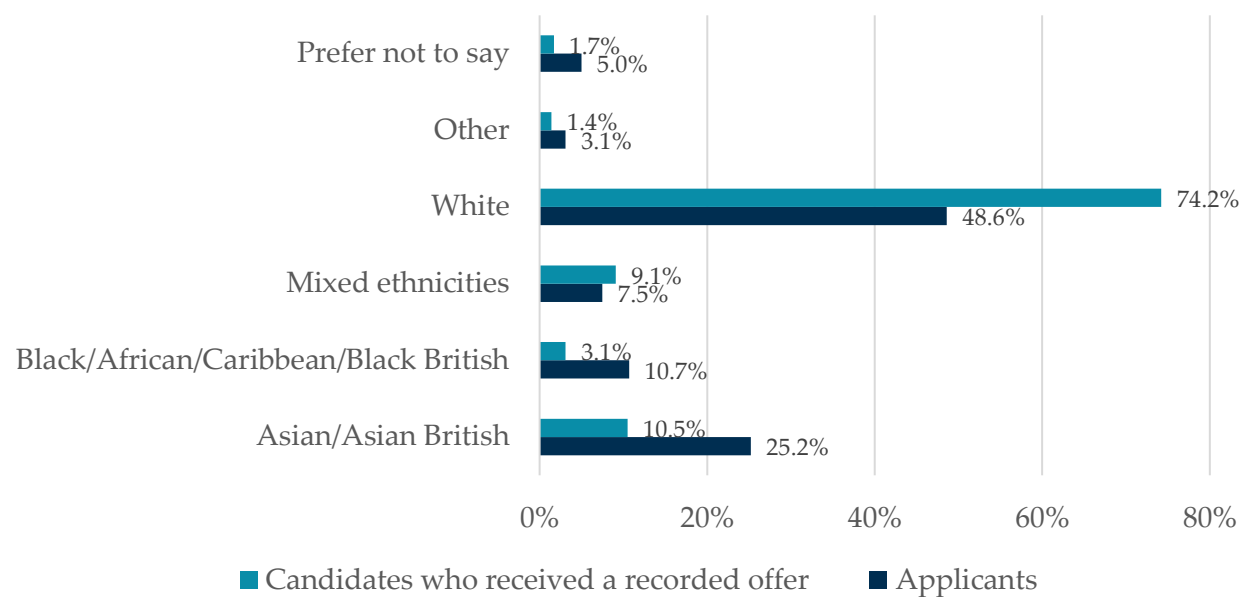
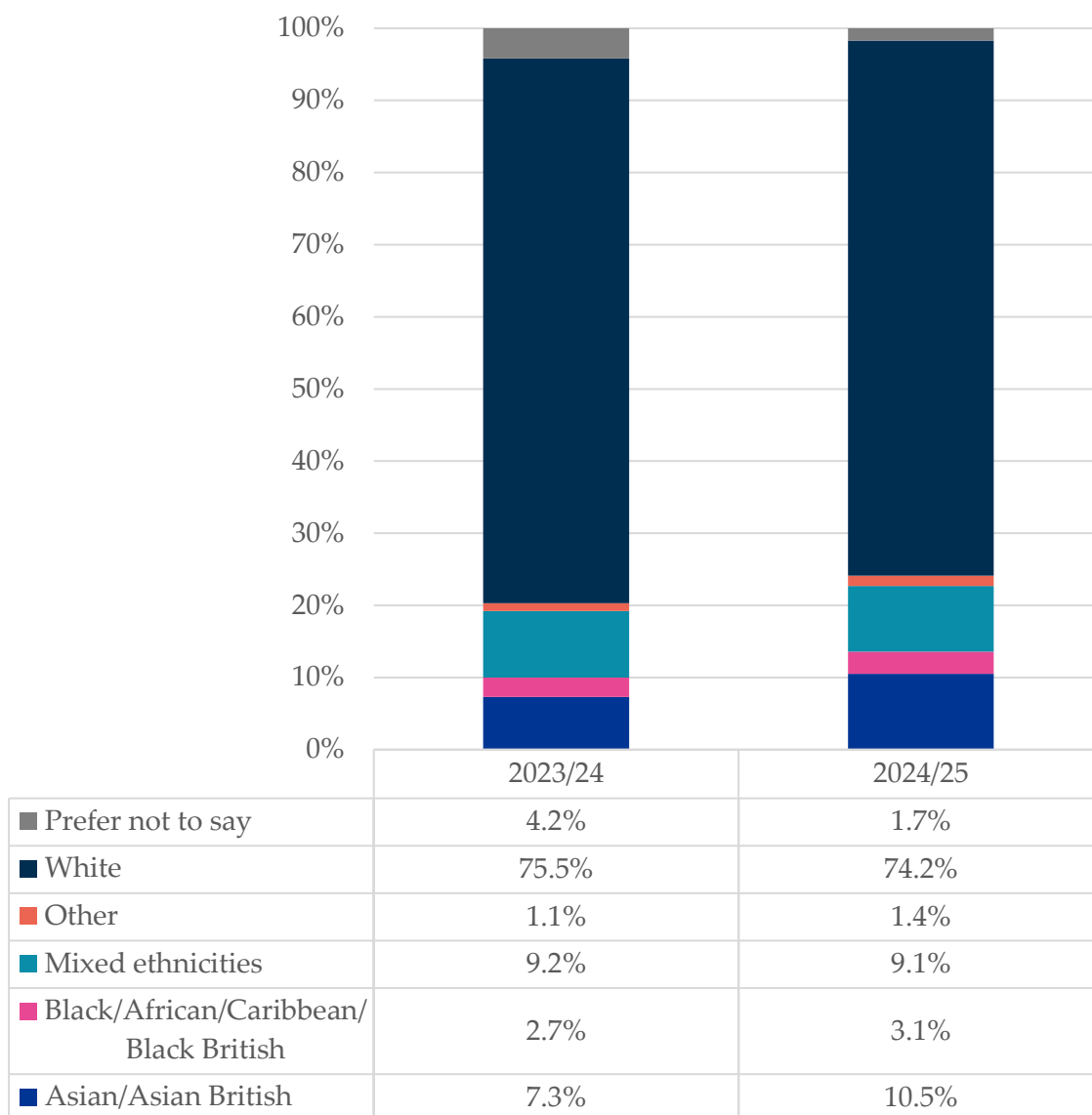


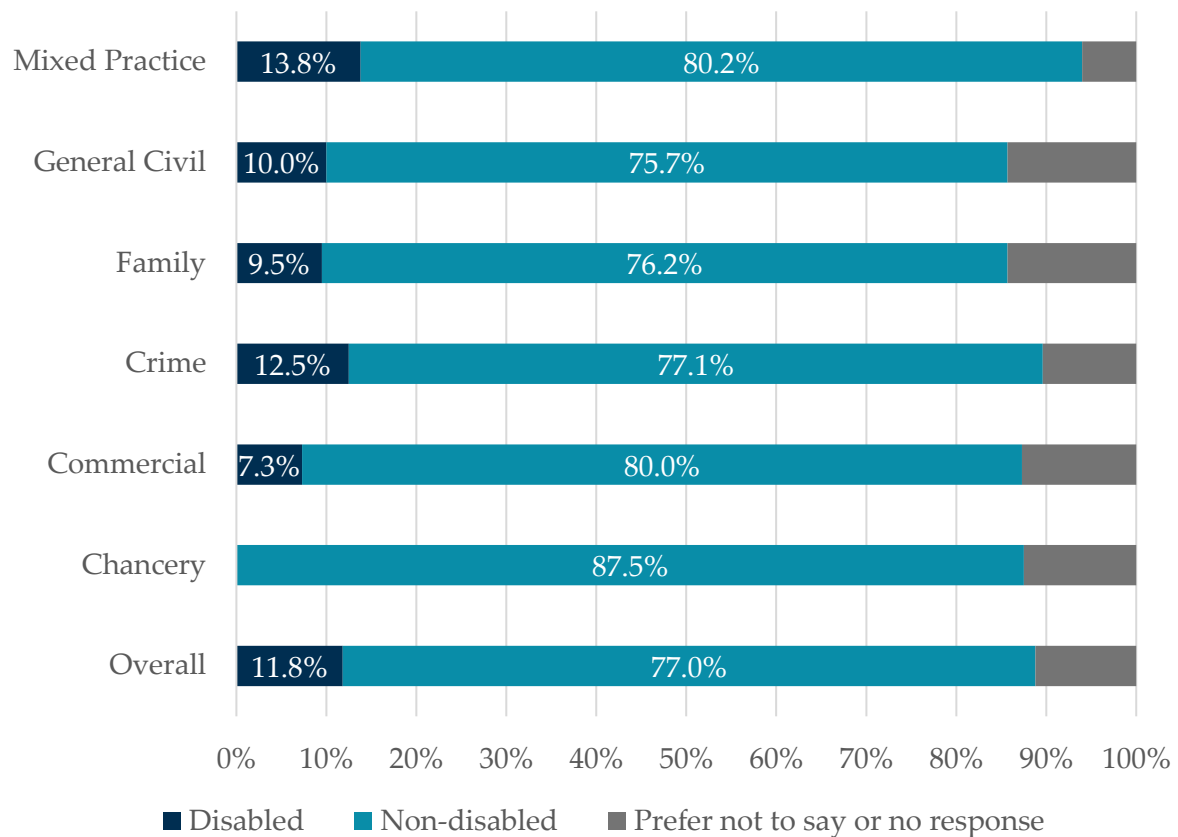
Figure C.1.2.b Percentage of overall pupillages offered via the Gateway by ethnicity, 2023/24 and 2024/25

Figure C.1.3 Percentage of pupillages offered via the Gateway by practice area and disability status in 2024/25²³

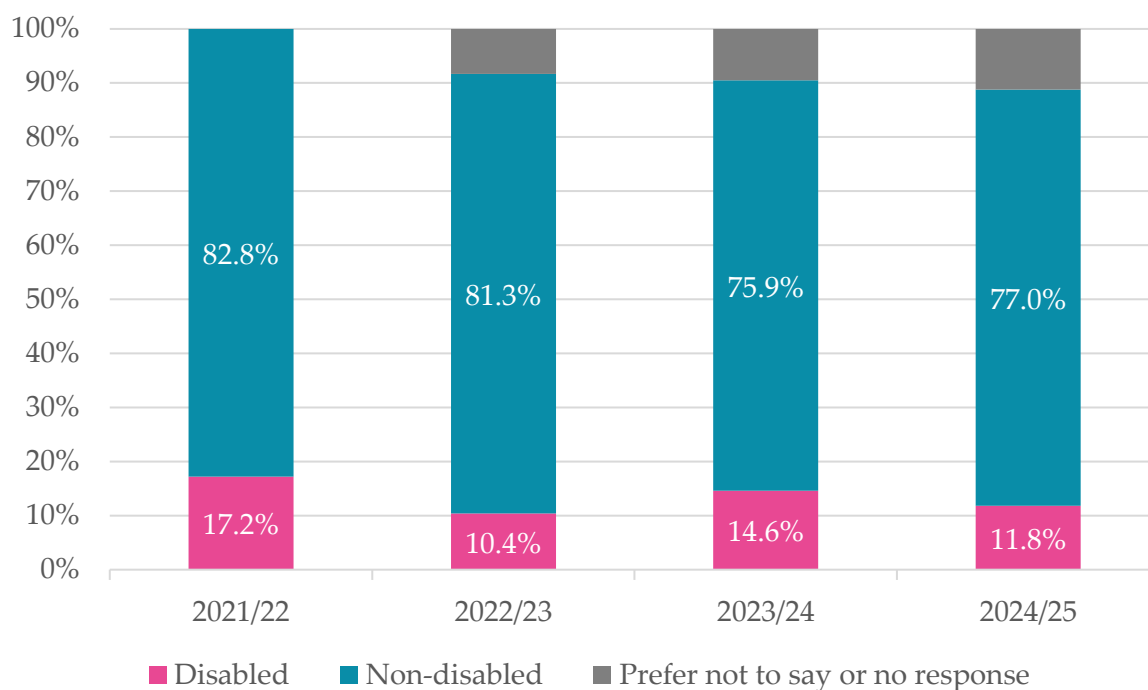

- Overall, the percentage of disabled candidates offered pupillage has decreased compared with 2023/24, but is above the level in 2022/23
 - General civil and mixed practices were the only two practice areas that saw an increase in the proportion of disabled candidates being offered pupillages

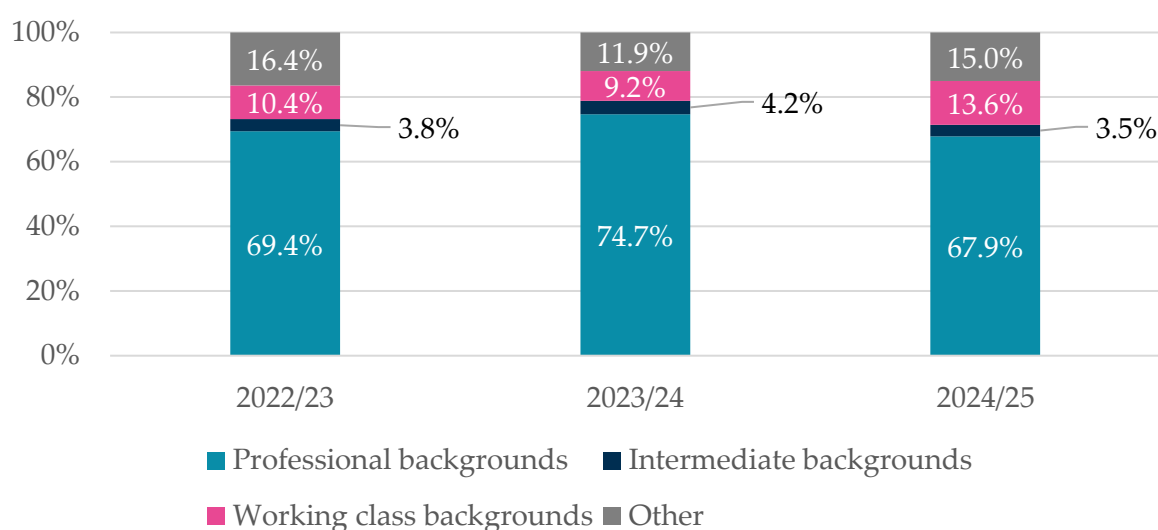
Section C2: outcomes based on socio-economic background

This section uses the Social Mobility Commission's Social Mobility Index (SMI) to assess socio-economic background, using indicators such as parental occupation, parental educational level and school type attended by applicants.²⁵ The Social Mobility Commission breaks parental occupation into three groups: professional, intermediate, and working class backgrounds.²⁶

We present the following data in isolation for each social mobility indicator. They have not been controlled with other factors such as academic attainment, scholarships or work/mini-pupillage experience.

Findings

Figure C.2.1 Percentage of candidates who received an offer via the Gateway by occupation of highest earning parent, 2022/23 to 2024/25²⁷



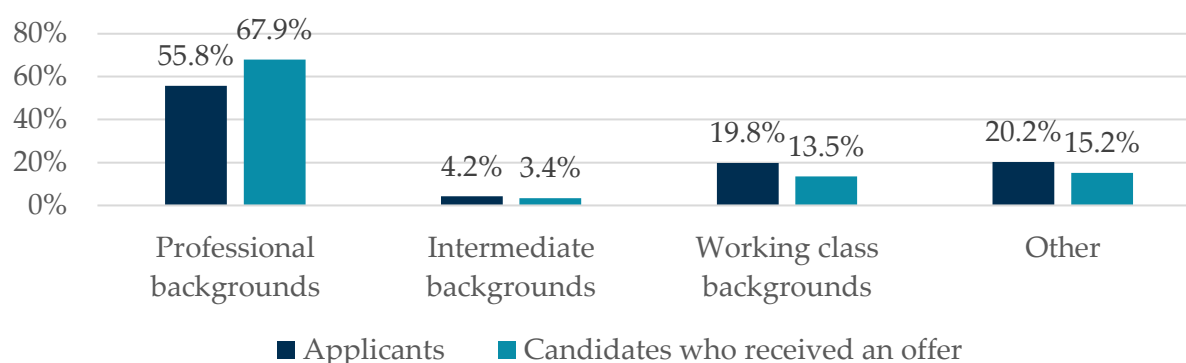

- In 2024/25, 67.9% of pupillage offers went to candidates from professional backgrounds, while 3.5% went to candidates from intermediate backgrounds and 13.6% went to candidates from working class backgrounds²⁸
- This marks a shift from 2023/24, when 74.7% of offers went to candidates from professional backgrounds, 4.2% from intermediate and 9.2% from working class backgrounds, suggesting a modest improvement in socio-economic diversity

Figure C.2.3 Percentage of candidates who received an offer via the Gateway by type of majority school attended, 2024/25³⁰

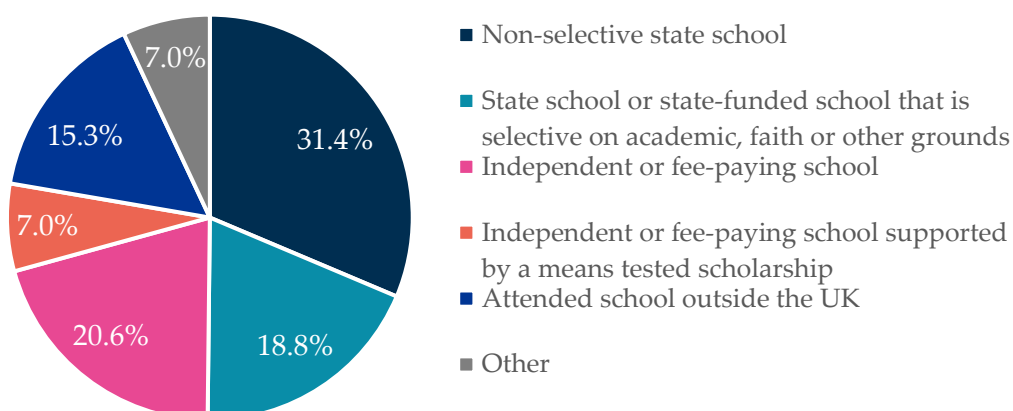
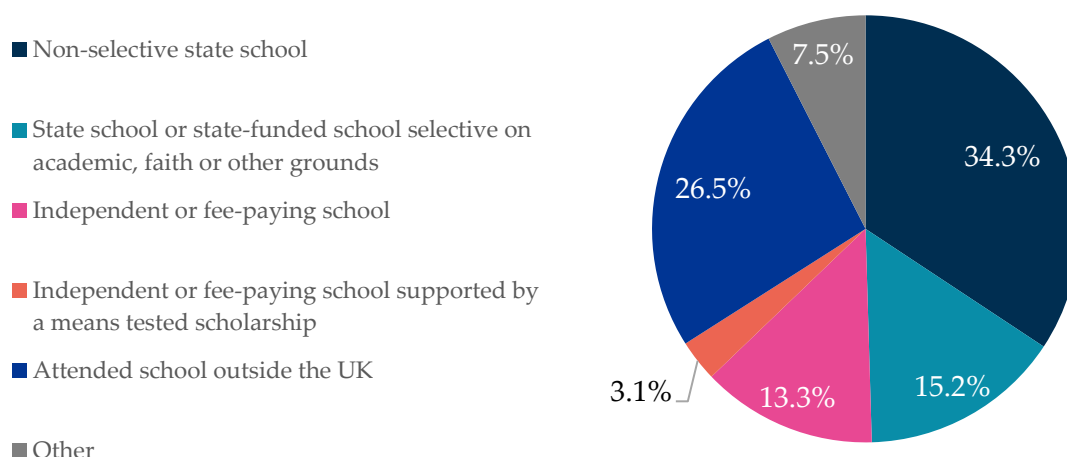


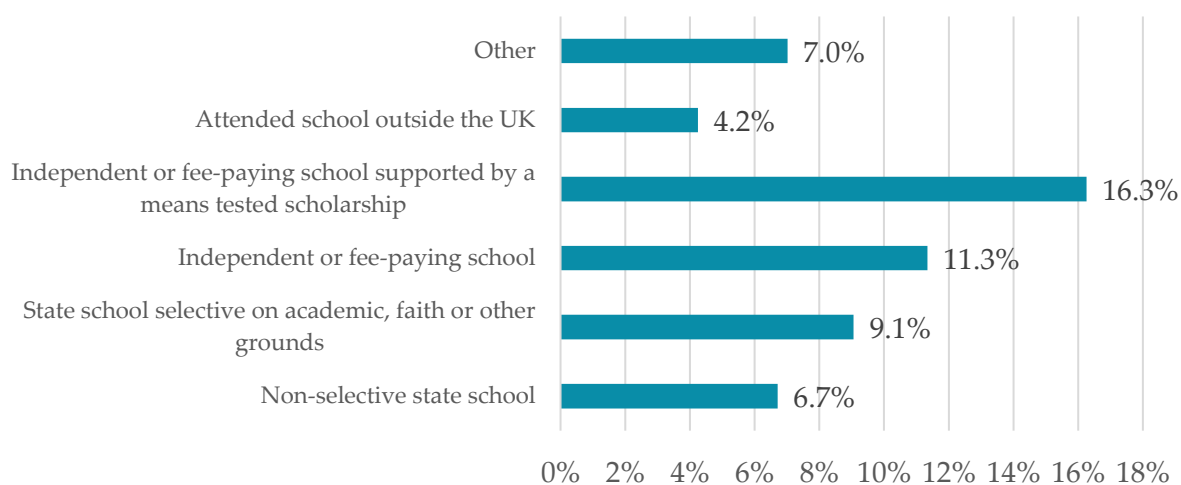
Figure C.2.4 Percentage of applicants by type of school attended, 2024/25

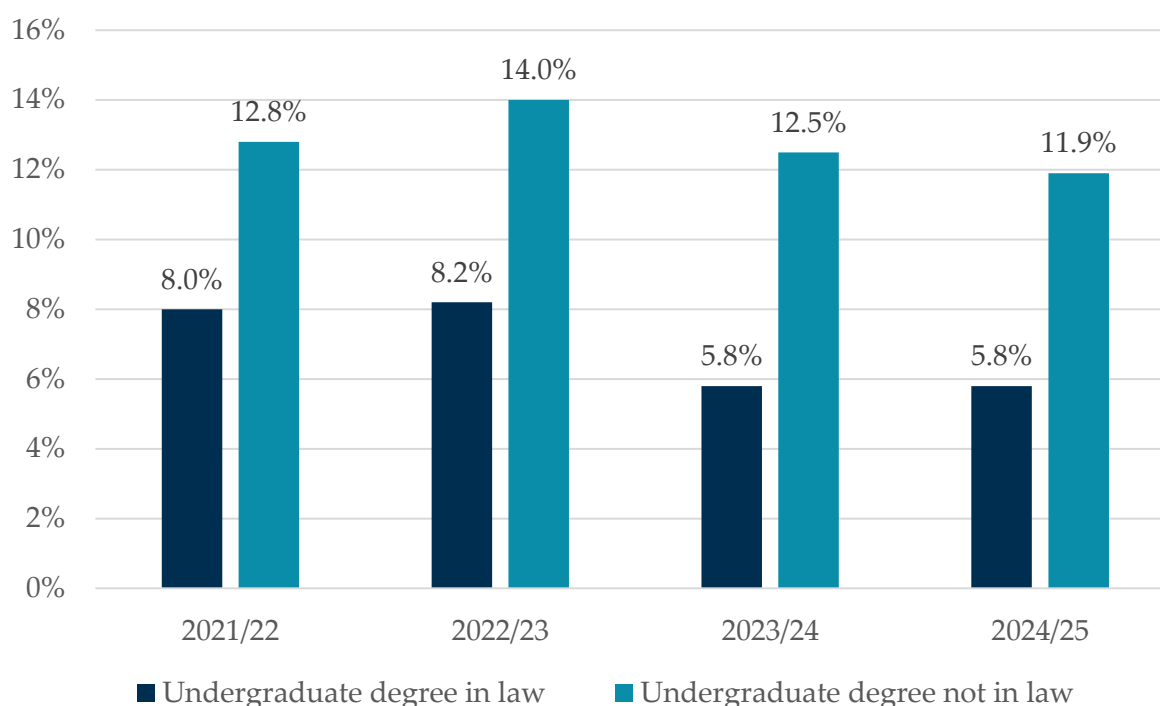
Figure C.2.5 Percentage of candidates offered pupillage via the Gateway by type of school attended, 2024/25

- Candidates that went to an independent or fee-paying school supported by a means-tested scholarship have the highest rate of receiving an offer (16.3%), whilst candidates that attended school outside the UK have the lowest rate of success (4.2%)

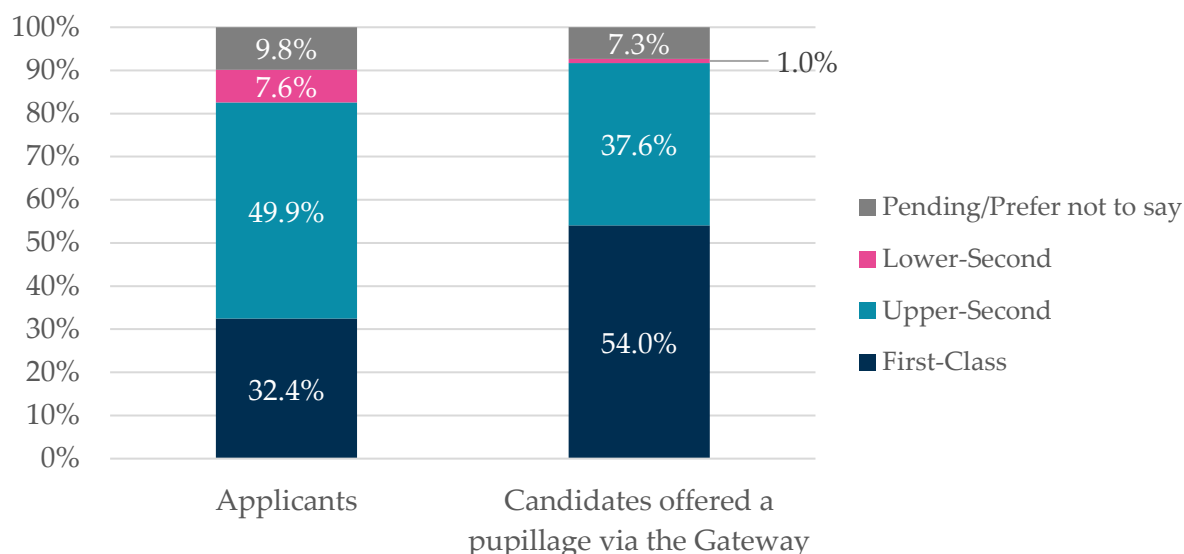
Figure C.3.1 Percentage of candidates offered a pupillage via the Gateway by type of undergraduate degree, 2021/22 to 2024/25³¹



- In 2024/25, 5.8% of candidates with an undergraduate degree in law were offered pupillage via the Gateway, whilst 11.9% of candidates with an undergraduate degree in a non-law subject were offered a pupillage via the Gateway
- Candidates who studied law for their undergraduate degree are not at an advantage when applying for pupillage

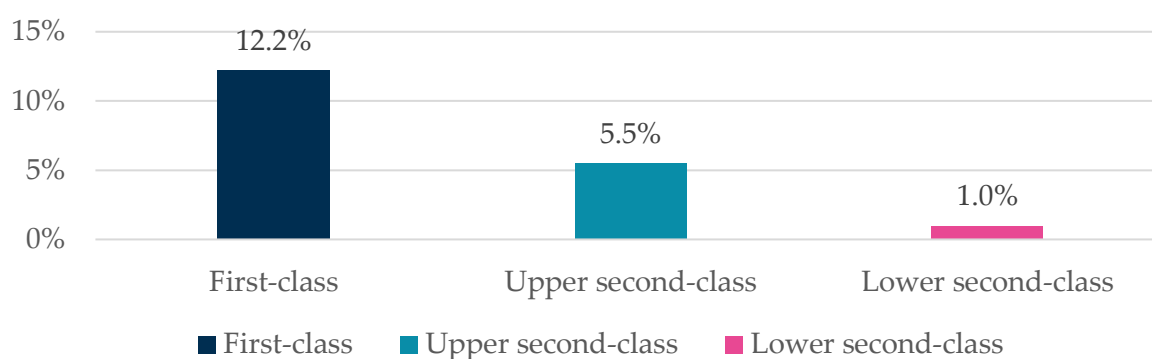

Figure C.3.2.a Breakdown of applicants and candidates offered a pupillage via the Gateway by undergraduate degree classification in 2024/25³²



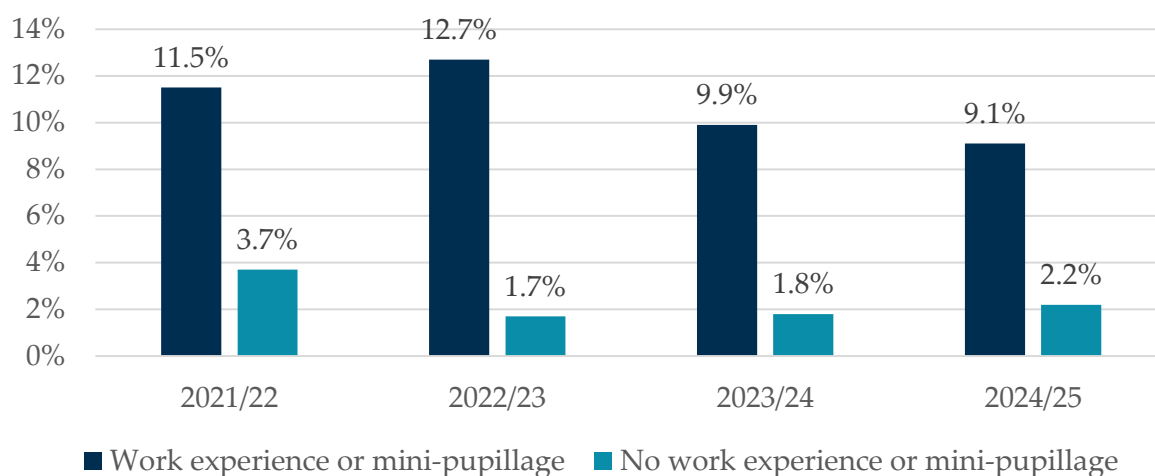
- Candidates with a first-class honours degree made up 32.4% of applicants but 54% of all recorded offers. Those with an upper second-class degree made up 49.9% of applicants but 37.6% of recorded pupillage offers
- For the first time in our recorded data, candidates with a lower second-class honours degree received recorded offers of pupillages. Applicants with a lower second-class degree made up 7.6% of applicants and 1% of candidates receiving recorded pupillage offers
- There continues to be an advantage held by first-class graduates in securing pupillage; they are more than twice as likely to secure pupillage as those with an upper second-class (see figure C.3.2.b)

Figure C.3.2.b Percentage of candidates offered a pupillage by undergraduate degree classification



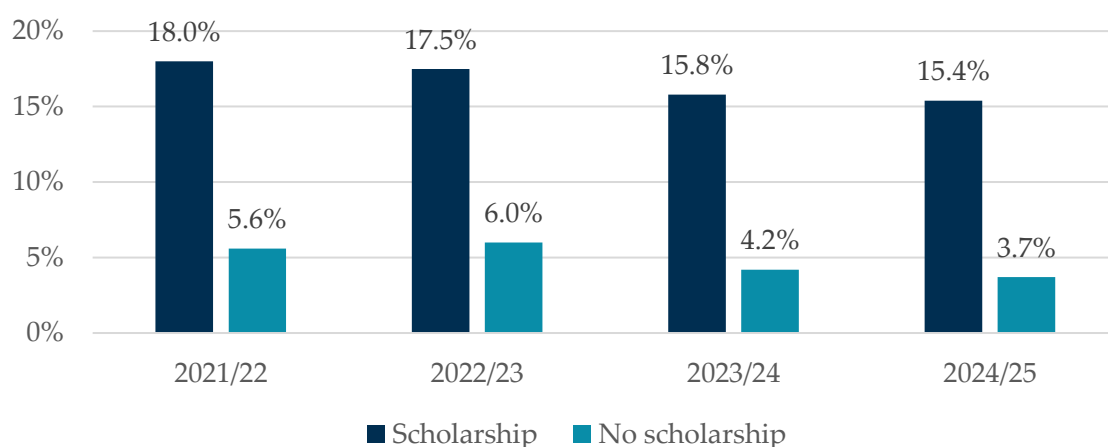

Figure C.3.4 Percentage of candidates offered a pupillage via the Gateway by scholarship status, 2021/22 to 2024/25³⁴

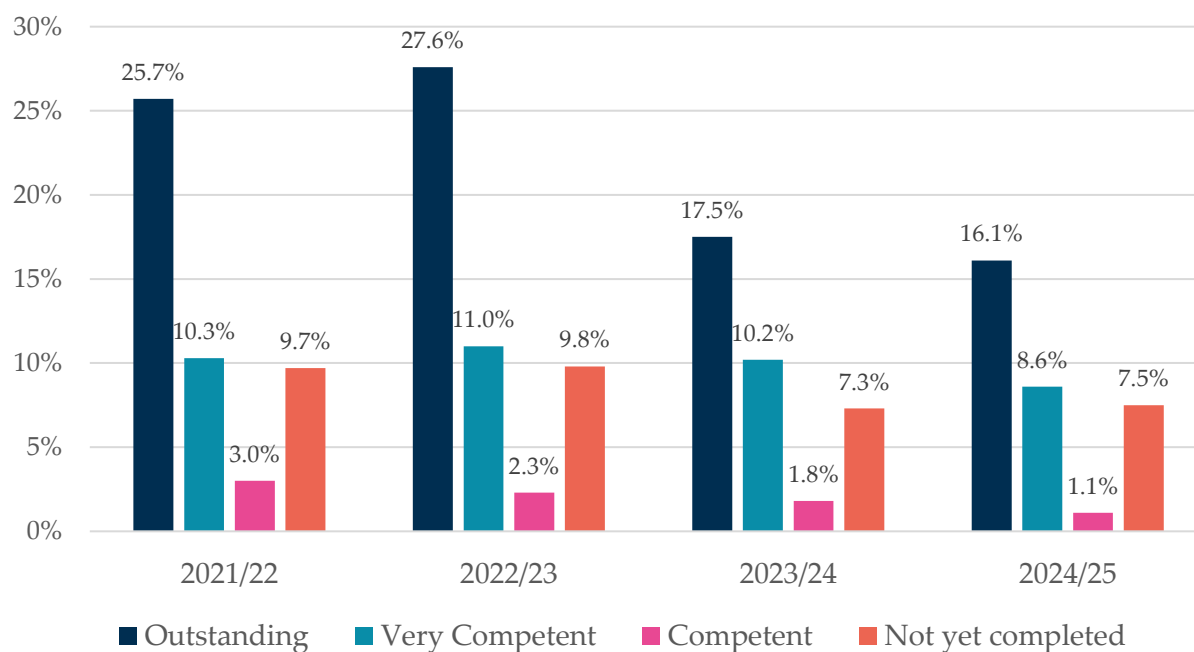

Figure C.1.1.b Percentage of Chancery pupillages offered via the Gateway by sex from 2021/22 to 2024/25

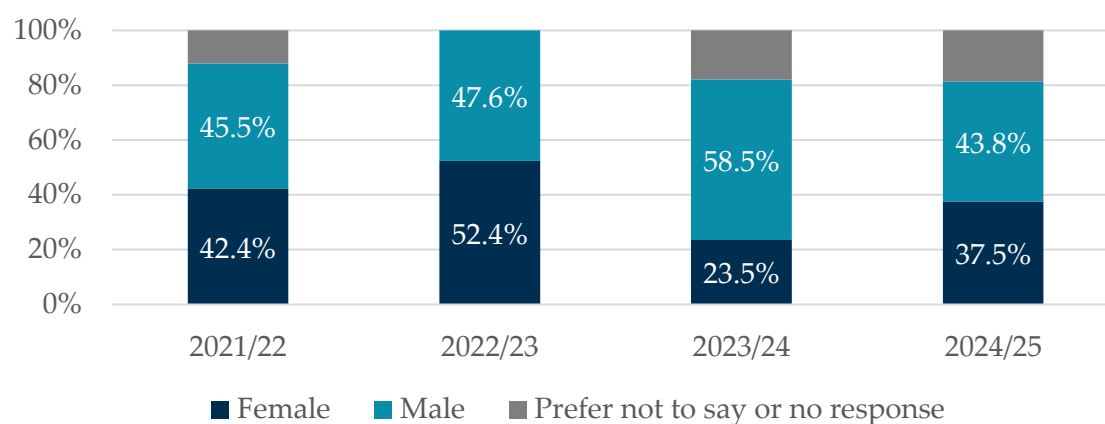


Figure C.1.1.c Percentage of commercial pupillages offered via the Gateway by sex, 2021/22 to 2024/25

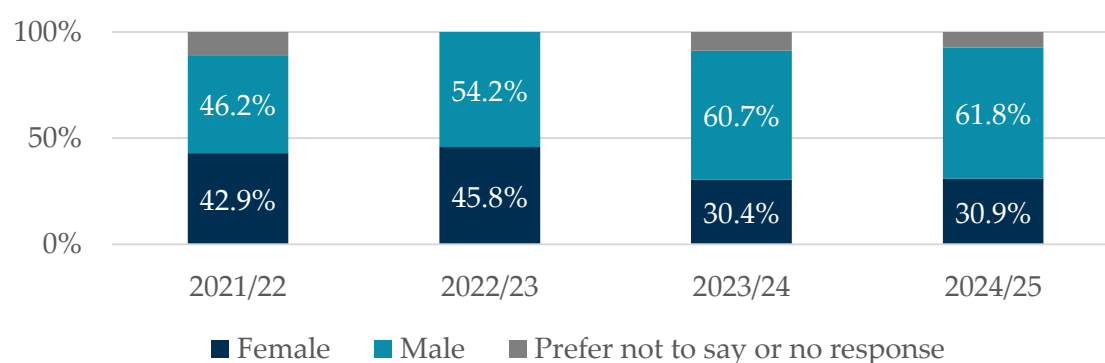


Figure C.1.1.d Percentage of crime pupillages offered via the Gateway by sex, 2021/22 to 2024/25

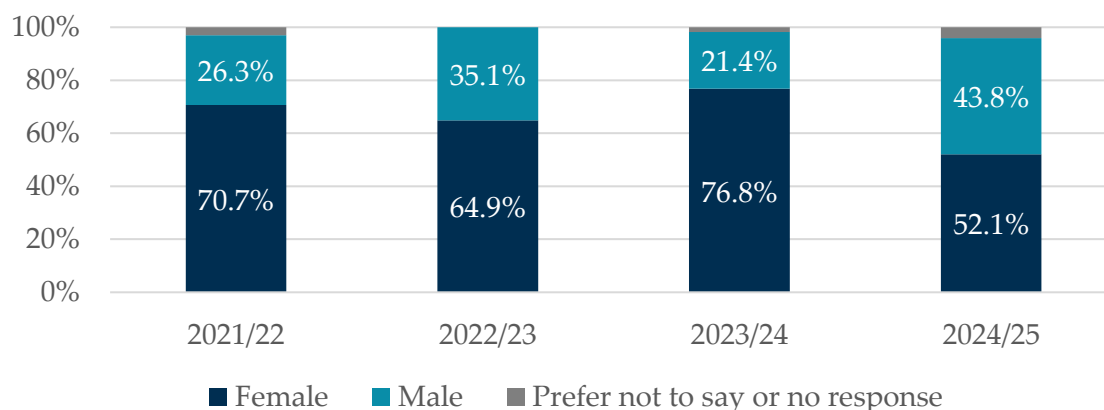


Figure C.1.1.e Percentage of family pupillages offered via the Gateway by sex, 2021/22 to 2024/25

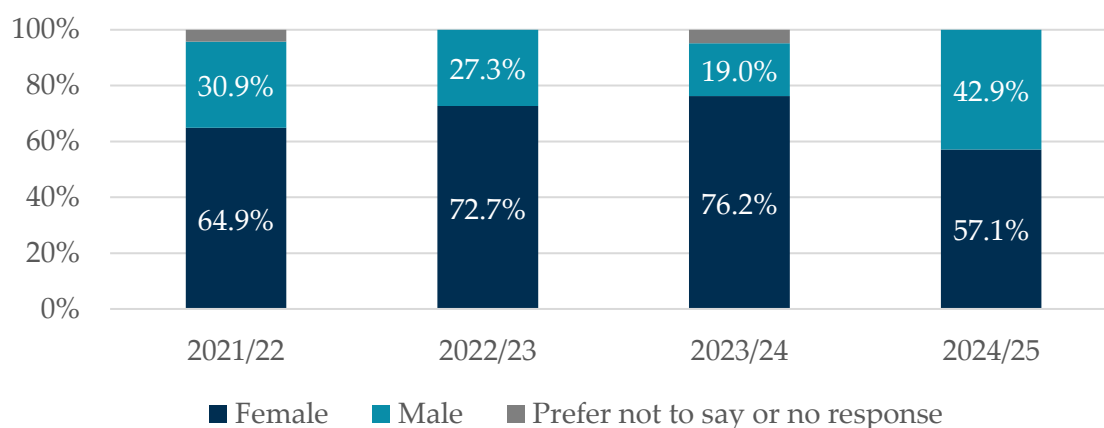


Figure C.1.1.f Percentage of general civil pupillages offered via the Gateway by sex, 2021/22 to 2024/25

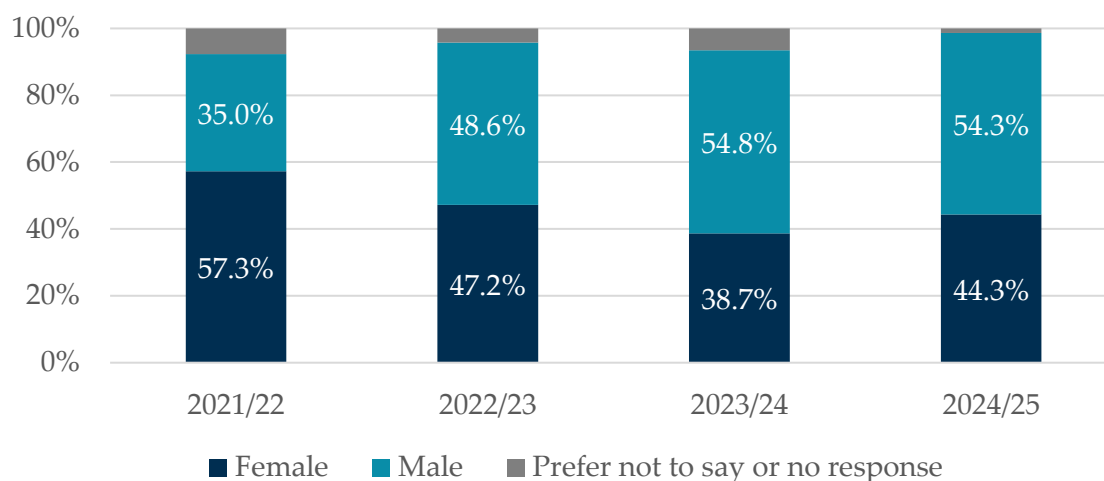


Figure C.1.1.g Percentage of mixed practice pupillages offered via the Gateway by sex from 2021/22 to 2024/25

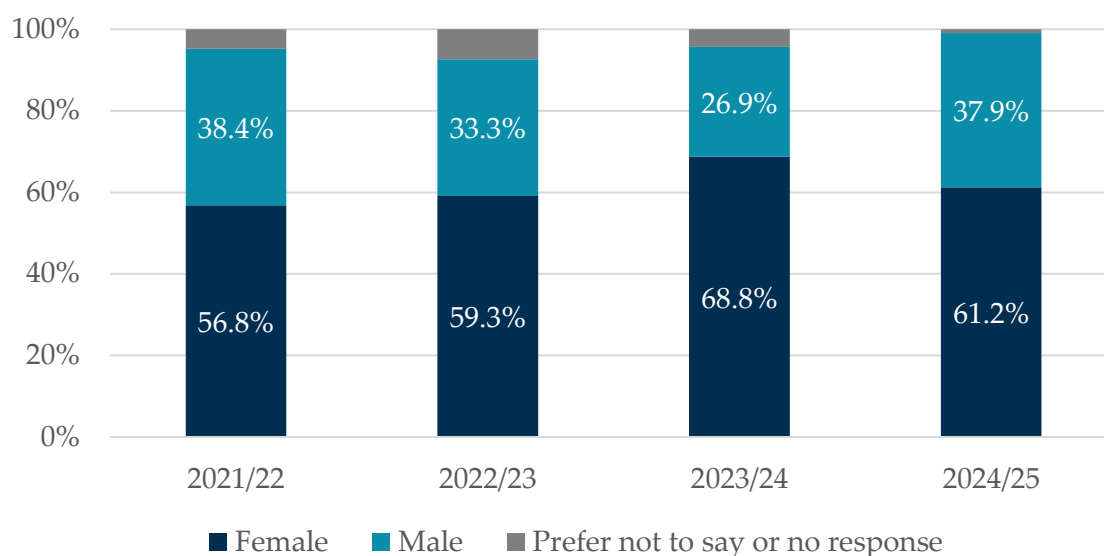

Figure C.1.3.b Percentage of Chancery pupillages offered via the Gateway by disability status and recruitment round

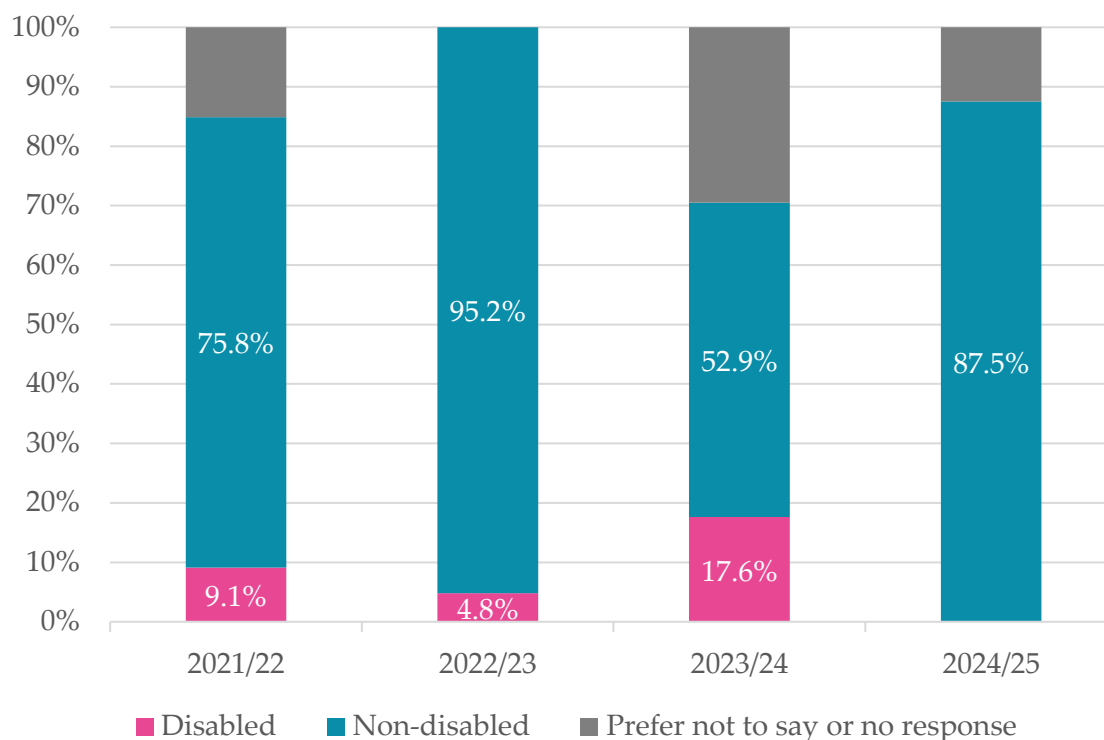


Figure C.1.3.c Percentage of commercial pupillages offered via the Gateway by disability status and recruitment round

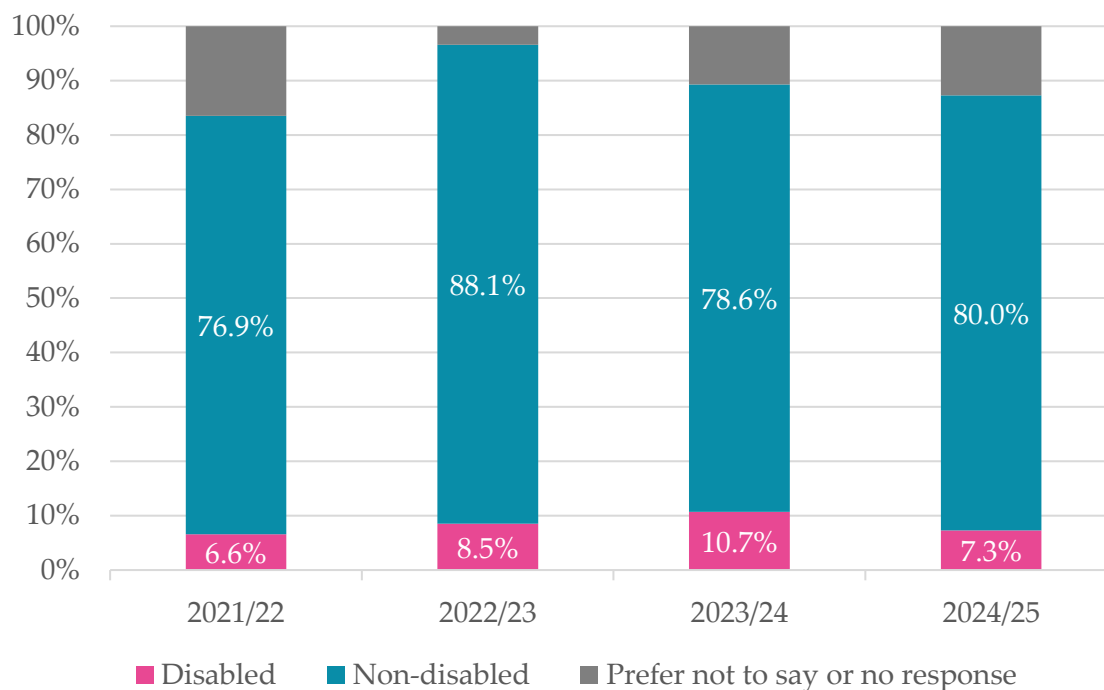


Figure C.1.3.d Percentage of crime pupillages offered via the Gateway by disability status and recruitment round

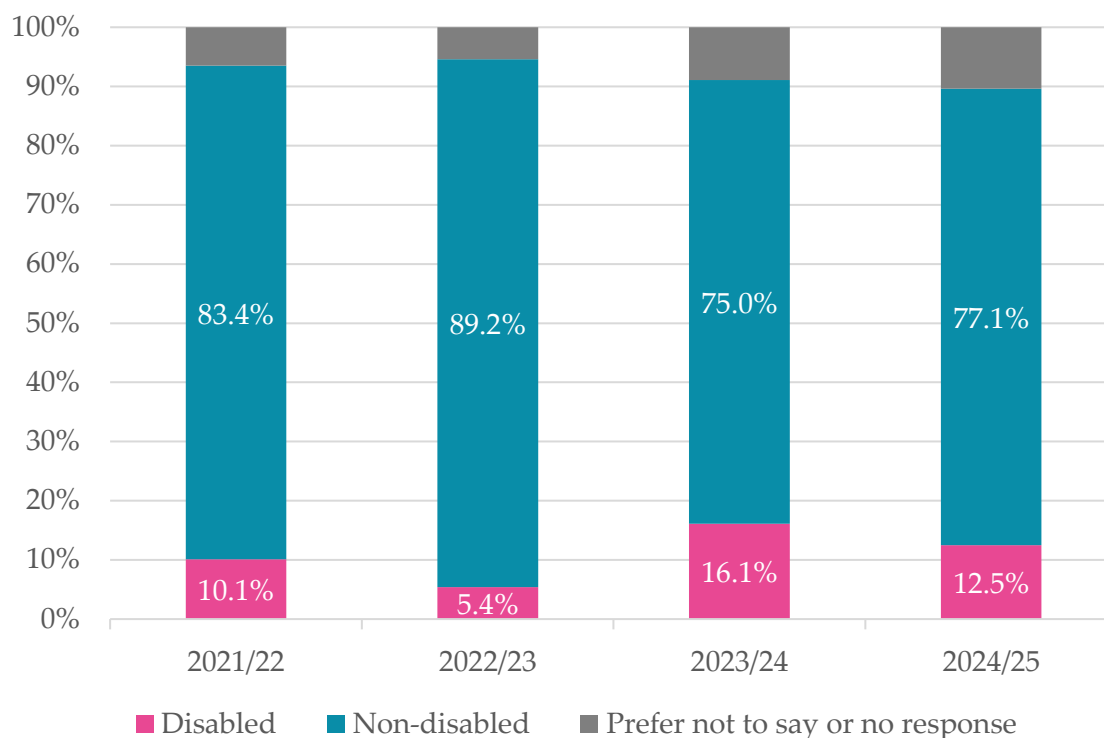


Figure C.1.3.e Percentage of family pupillages offered via the Gateway by disability status and recruitment round

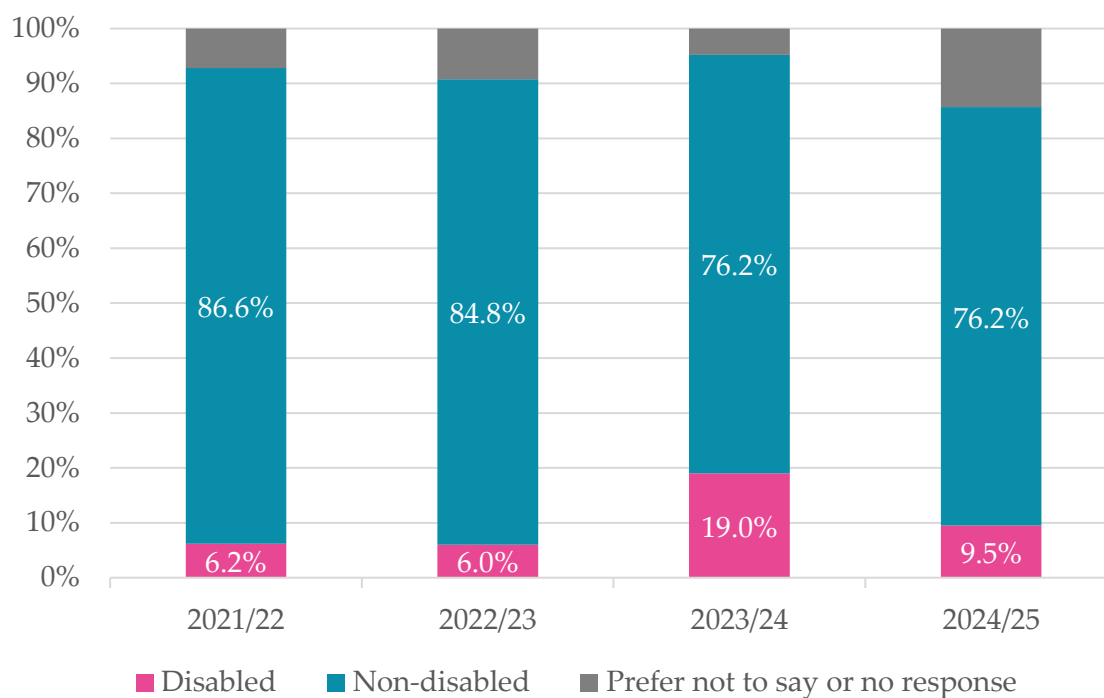


Figure C.1.3.f Percentage of general civil pupillages offered via the Gateway by disability status and recruitment round

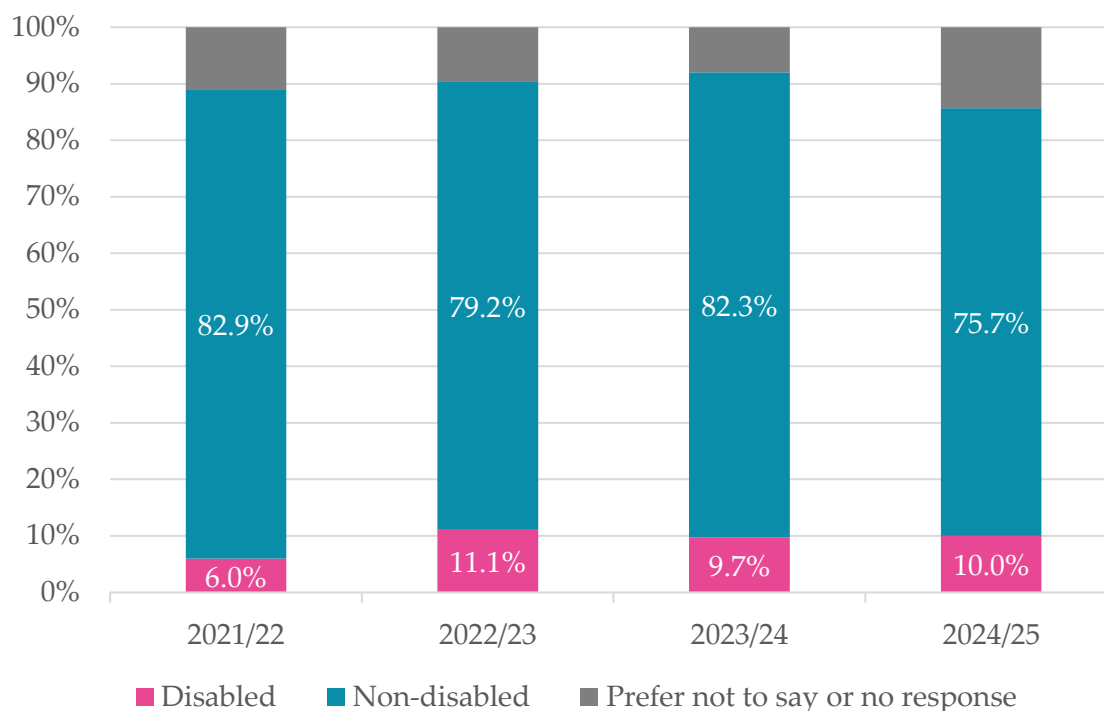


Figure C.1.3.g Percentage of mixed practice pupillages offered via Gateway by disability status and recruitment round

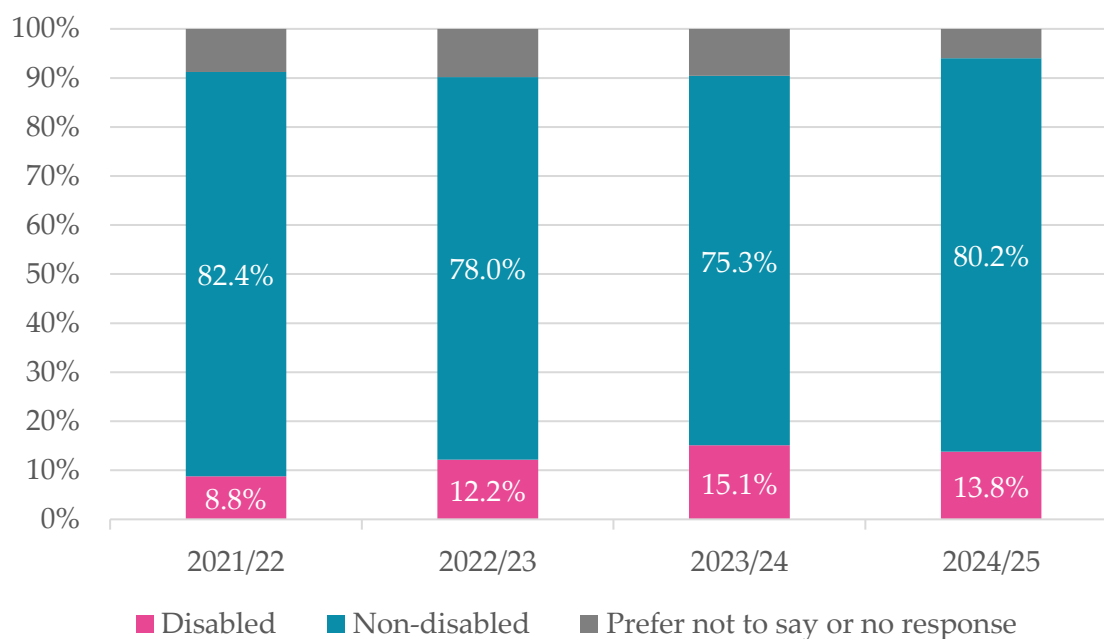
